

# Unit of Study Guide: BUS1006 Introduction to Business Law Trimester 1 2023

#### Overview

This unit introduces students to the fundamentals of business law and the Australian legal environment. It begins with an overview of the sources of law in society and the Australian lawmaking process, before examining topics such as the formation, operation, and termination of contracts, the nature of consumer law, trade practises law, and the law as it applies to different business structures. The unit also introduces the concept of agency.

This unit places emphasis on logical and critical thinking and requires students to apply these skills to the identification and resolution of legal problems through case study analysis and as they apply to business.
